**Working Policy: Scholarships**

1. Assuming that the Chapter budget permits, it is the policy of the Mile High Chapter to make financial assistance available to any member, in good standing, who wishes to attend a national conference.
2. The Chapter will provide an application form, establishing criteria similar to that used for NACBA's Endowment Fund scholarships.
3. The Chapter established the practice of funding the incoming Chapter President's registration to attend the national conference in 1997, as a way of assuring the Chapter's representation at these annual events.
4. Applications will be reviewed and approved by the Executive Committee of Mile High Chapter's Board of Directors. If one or more members of the Executive Committee are among the applicants, the President shall appoint an adhoc committee of at least four other Chapter members who are members of the national association as well, to join him/her in making the necessary determinations.
5. The amount awarded to any individual will not exceed \$250.00; no individual can receive more than one scholarship in any program year.
